# D. Budget Review

- a. January 31st marked 58.33% into the fiscal year (FY22). We are at an income of 86.76% and expenditures are at 63.24%, making our combined revenue less expenditures 58.41%. There were 3 pay periods in January which is why Regular Salaries are high. We are trending higher in books and materials, which is often the case. We will have some savings in other line items that we'll be able to shift funds later in the year.
- **b. Library Foundation 2021 Funds Report:** The Library Foundation saw an increase of 72.36% in their holdings due largely to the Donald & Vera Steeve \$30,871 estate. The Foundation also moved

from CDs to invested funds. They moved \$84,000 to a managed Farm Bureau Financial Services account (mostly Vanguard Funds) and invested \$10,000 into the Clarinda Foundation's invested funds—which grew by \$8,500 + due to the Giving Tuesday program held in November.

- **a.** Page County Librarians Meeting: Met in Essex. Andrew wasn't able to attend. The BOS did approve the request to increase funds for next year. An increase of \$2,200 or 16% to \$16,140 for Clarinda. These funds will be used to cover the cost of additional hotspots.
- **b.** Page County Community Foundation Grant Request: Andrew submitted a grant for A Glowforge Laser Cutter and Engraver this would add to the Makerspace area at the library that includes the 3D printer. The request was for half of the \$9,900 project with the other half requested from the Clarinda Library Foundation.
