# Internet Safety Policy <br> For Clarinda Lied Public Library 

## Introduction

It is the policy of Clarinda Lied Public Library to: (a) prevent user access over its computer network to, or transmission of, inappropriate material via Internet, electronic mail, or other forms of direct electronic communications; (b) prevent unauthorized access and other unlawful online activity; (c) prevent unauthorized online disclosure, use, or dissemination of personal identification information of minors; and (d) comply with the Children's Internet Protection Act [Pub. L. No. 106-554 and 47USC 254(h)].

## Definitions

Key terms are as defined in the Children's Internet Protection Act.*

## Access to Inappropriate Material

To the extent practical, technology protection measures (or "Internet filters") shall be used to block or filter Internet, or other forms of electronic communications, access to inappropriate information.

Specifically, as required by the Children's Internet Protection Act, blocking shall be applied to visual depictions of material deemed obscene or child pornography, or to any material deemed harmful to minors.

Subject to staff supervision, technology protection measure may disabled for adults or, in the case of minors, minimized only for bona fide research or other lawful purposes.

## Inappropriate Network Usage

To the extent practical, steps shall be taken to promote the safety and security of users of the Clarinda Lied Public Library online computer network when using electronic mail, chat rooms, instant messaging, and other forms of direct electronic communications.

Specifically, as required by the Children's Internet Protection Act, prevention of inappropriate network usage includes: (a) unauthorized access, including so-called 'hacking,' and other unlawful activities; and (b) unauthorized disclosure, use, and dissemination of personal identification information regarding minors.

## Education, Supervision and Monitoring

It shall be the responsibility of all members of the Clarinda Lied Public Library staff to educate, supervise and monitor appropriate usage of the online computer network and access to the Internet in accordance with this policy, the Children's Internet Protection Act, and the Protecting Children in the $21^{\text {st }}$ Century Act.

Procedures for disabling or otherwise modifying any technology protection measures shall be the responsibility of the Library Director or designated representatives.

The Library Director or designated representatives will provide age-appropriate training for students who use the Clarinda Lied Public Library's Internet facilities. The training provided will be designed to promote the Clarinda Lied Public Library's commitment to:
a. The standards and acceptable use of Internet services as set forth in the Clarinda Lied Public Library's Internet Safety Policy;
b. Student safety with regard to:
i. safety on the Internet;
ii. appropriate behavior while online, on social networking Wed sites, and in chat rooms; and
iii. cyberbullying awareness and response.
c. Compliance with the E-rate requirements of the Children's Internet Protection Act ("CIPA").

Following receipt of this training, the student will acknowledge that he/she received the training, understood it, and will follow the provisions of the library's acceptable use policies.

## Adoption

This Internet Safety Policy was adopted by the Clarinda Lied Library Board at a public meeting, following normal public notice, on, $11-19-15$.
